

## **2011 Spring Decisions**

### **Matters Decided by R&D Committee with Hearings**

#### ***Overage Player***

**U12** – After season it was discovered PWSI used U14 player on U12 team with someone else's identity and birth certificate. Player suspended indefinitely, team suspended for 1 season, coach suspended for 9 games when team can return to NCSL play.

#### ***Underage Player Beyond NCSL Restriction***

**U11** – After season it was discovered SSA used a fourth underage player on team with false birth certificate (NCSL restricts teams at this age to 3 underage players) saying he was not underage, player suspended for 2 games, father suspended for season, coach suspended for 3 games.

### **Coach Failure to Honor Suspension & Comply with Sit Out Rules**

**U16/2**– After the season it was discovered a CALV coach failed to honor a suspension that was owed going into the season for past violation of sit out rules, and again failed to comply with sit out rules during the season. As a result, without any adjustment, he would owe at least 5 sit outs going into the next season. Coach suspended for season, and team fined \$250.

**U15/3** – After the season it was discovered a CALV coach failed to honor a suspension that was owed going into the season for past violation of sit out rules, and again failed to comply with sit out rules during the season. As a result, without any adjustment, he would owe at least 9 sit outs going into the next season. Coach suspended for two seasons, and team fined \$250.

### **Matters Decided by R&D Committee without Hearings**

#### ***Protest Denied***

#### ***Missing Second Assistant Referee***

**U16/4** – REST protests results of game where their team lost 3-0, and a player and assistant coach were ejected, on basis that one of the assigned assistant referees didn't show at game, and the center referee failed to replace him. Protest denied for it failed to establish a rule violation that affected the outcome of a game.

### **Matters Resolved By Clubs Endorsed by R&D**

#### **Players**

#### ***Use of Racial Epithets***

**U16/5** – SEVP player makes racial epithets to opponent, suspended for 1 game.

**U13/6** – SEVP player makes racial epithets to opponent, suspended for 1 game.

### ***Violent Conduct***

**U16/4** – LOUD player is ejected for punching opponent, suspended for 1 game in addition to red card sit out.

### ***Misconduct After Ejection***

**U16/2** – CALV player ejected for shoving opponent, shoves another opponent as he leaves field, suspended for 2 games in addition to red card sit out.

**U15/1** – ABGC player uses foul & abusive language after ejection, 1 game suspension in addition to red card sit out.

### ***Misconduct After Game***

**U15/6** – REST player makes obscene gesture to referee after game, 1 game suspension.

### **Coaches**

#### ***Violation of Sit out Rules***

**U15/6** – Suspended LOUD coach came to game while serving last of prior R&D suspension, suspended for remainder of season.

**U13/3** – Sitting out STER assistant coach comes to game while serving sit out, sit out doesn't count, and suspended for 2 additional games.

#### ***Failing to Leave or Returning to Field After Ejection***

**U14/5** – Ejected SYA coach and assistant coach remain at field after ejection, both given 1 game suspension in addition to red card sit out.

**U16/4** – Ejected MCLN coach remains at corner flag after ejection, and immediately after game, confronts referee, suspended for 2 games in addition to red card sit out, and banned from coaching for one season and until he completes a number of PCA courses.

**U16/4** – Ejected REST assistant coach returns to field after ejection, suspended for 1 game in addition to red card sit out.

**U15/5** – Ejected PWSI coach first doesn't leave, and then when referee insists, utters obscenities about referee, suspended for 3 games in addition to red card sit out.

**U13/3** – Ejected BETH coach remains at field (ejected for his rant about female referees), suspended for 2 games in addition to red card sit out, and 2 sit outs for second red card in season thereby reaching accumulated points threshold, for a total of 5 games.

**U11/4** – Ejected VYS coach returns to field after game to apologize to referee, probation for remainder of season.

**U10** – Ejected STER coach fails to leave field, suspended 1 game in addition to red card sit out.

### ***Other Misconduct***

**U 19/2** – OLNK assistant coach gets into argument with opponent player during handshake, suspended for 1 game.

**U16/2** – ASA coach mutters obscenities towards opponent players at end of the game, suspended for 1 game.

**U13/6** – CYA coach yells at referee throughout the game, 1 game suspension.

**U13/5** – REST coach is disrespectful to referee, assistant referee and opponent coach (possibly with racial epithets), suspended for 2 games.

**U12/6** – STER coach fails to control sideline when parent confronts referee and opposing team's STAR during half-time, coach suspended for 1 game (see also below, where parent from same game is suspended for 2 games for confronting referee and opposing team STAR ).

**U14/2** – ASA coach tells players to stop playing so that he could address referee, suspended for 1 game.

**U10** – NVSC coach mutters derogatory comment at referee after game, suspended for 1 game.

### **Affiliates**

**U15/4** – NVSC parent makes inappropriate comment to referee after game, suspended for 1 game.

**U15/3** – MSC parent confronts assistant referee after the game, suspended for 1 game and cannot attend future games until he completes online PCA parent's course.

**U15/2** – CALV parent ejected for "threatening" referee, suspended for 2 next games.

**U15/2** – NVSC parent of injured player comes onto field to confront referee, suspended for 1 game.

**U12/6** – STER parent confronts referee and opposing team's STAR during half-time, suspended for 2 games (see also above, where coach from same game suspended for 1 game for not controlling sideline).

**U11/3** – BRYC parent ejected for yelling at referee, suspended for 1 game.

**11/2** – Injured SSA player's father comes onto field screaming obscenities, suspended for 1 game.

**U10** – Ejected LAUR parent continues to yell at referee as she leaves field, suspended for 1 game.
